TERMS AND CONDITION

- You must bring a valid photo ID as an original passport or CNIC. It is recommended that you bring a
 passport. If you do not bring original ID; your exam will be cancelled and no refund will be made nor the
 date be postponed.
- No mobile phones /electronic devices are allowed in exam room
- In case of withdrawal of the test the refund policy is as follows
 - a) 100% refund before deadline
 - b) 50% refund within 5 days after deadlines
 - c) No refund after 5 days after deadline
- In case of late registration (up to 5 days after deadline) a late fee of Rs. 5000, other than the normal charges will apply
- Your speaking test may or may not be on the same day as the Reading, Writing and Listening tests
- You need to abide by the timings on all test dates. In case you arrive late, or do not appear your test may be cancelled without any refund
- A minimum number of 6 candidates on any given date are required to commence a test. In case the minimum number is not achieved your test will automatically be postponed till the next test date. In case you want to pursue the test on the same date, the center may arrange an exclusive test for you on the same date with an additional cost.
- No eatables are allowed within the exam premises. However, you may bring a medicine (if prescribed) and/or a clear water bottle (without tags)
- You must make an appearance at the center at least one day before the test.
- You consent to have any photo taken by the center on the day of test. You agree for this photo to be held
 on the secure Cambridge English results verification site, and the photo shall only be available to
 organizations/ individuals that we give your details to or that you authorize to view your result via a
 download. You consent that these organizations and individuals can use these details to verify your
 examination result.
- By submitting this form you declare that you are aware of and agree to comply with terms and conditions for the examination. Also, you acknowledge to abide by the clauses in the "Notice to candidates" available in the download area of the website.
